## NEW YORK ALWAYS ON TICKET

(Continued from First Page.)

buildings which have been built in Washington during the last four years there is the home of the Daughters of the American Revolution and the Tuture home of the Bureau of American Republics, the gift of Andrew Carnegie, which has just been started. But the greatest change will be found in the appearance of the Treasury department itself. The east front of that structure is ornamented with thirty Ionic columns built up of Virginia freeatone. The main walls behind these columns are of the same material. The winds and the rains of fifty years have caused this material to crumble and more than a year ago congress decided to rebuild the main portion of the east front by substituting granite facings for the freestone and granite monoliths so as to make the whole front conform in appearance to the two ends, which were added to the original building.

Bix of these monoliths are in the city at the present time and the remainder have been quarried and are now being dressed. The task of removal has already begun and before the end of the current year it will have been completed. The original treasury building was completed in 1840, but it was not until fifteen years later that the wings were added and then more than a quarter of a century passed before additions in the form of basements, subcellars and approaches were added. Up to the present time the building has cost about \$7,000,000 and the rebuilding of the east front and substitution of granite monliths for the sandstone lonte columns will add \$300,000 more to the total cost

Sleeping Car Rates Next. Although the so-called Hepburn rate bill. which became a law more than a year ago, provided that the sleeping car companies and express companies shall be regarded as common carriers' thereafter and as such shall be brought within the purview of the Interstate Commerce commission, that body up to the present time has formulated no regulations affecting the express and sleeping cap business of the country.

The commission, however, has been gathering facts concerning the rates and discriminations made by these companies and within a short time the public will learn they have some rights which the corporations controlling these utilities are bound to respect. The facts in regard to the sleeping car companies will be particularly interesting when made public. It is learned that the commission has gathered a mass of information which shows there appears to be absolutely no system in the method of fixing rates. For instance: It is possible to go to Chicago from Washington for \$4.50 if the passenger buys a ticket half way and then renews his right to occupy his berth for the remainder of the journey. But if he buys right through he compelled to pay \$5 for like accommodation. This is only one instance called to the attention of the commission to the injustice of the present method of charging by the sleeping car company and it is one which will be remedled with many similar when the regulations are formulated.
