Recent legislative events have disclosed that there are two very distinct schools of thought relative to the regulation of public service corporations in the cities and towns of lowa and those of statewide character. It was found in the senate discussion of the Van Law blil to give cities the right of inquiry before acting in matters of regulation, that practically all those who oppose making it possible to regulate city franchises are favorable to the White Grier plan of having the state take over. through a commission, all the powers now vested in the municipalities. It also showed that as between the White-Grier bill and the Smith-Lee bill there is a wide difference. One senator explains his position in

regard to his bill as follows; "The state should undertake to regulate all those public service corporations that are not now regulated or that may not be The quality for the price is so kept in regulation, but the fact is that these franchises for water, gas, etc., in our cities are under the control of the muncipalities and are now regulated. No state ommission can take over control of these without taking the authority away from the people most directly interested. As far as we ought to go now is to give to a state commission the authority to regulate where the municipalities cannot very well do so. as in the case of telephones, telegraphs and interurbans. When we have done that we have provided that all corporations shall be subject to regulation."

In the hearing which was given on the two bills in the house committee on railroads, it was brought out the other day that the plan of having one state commission undertake the regulation and control of all local public utilities has proved an expensive luxury in New York. In response to an inquiry it was brought out that the first year of its operation the upstate commission cost \$285.000. Of course. it was stated, that Iowa ought not to cost as much, but the figures were given to indicate how expensive it is to handle franchise matters from a central point. The nission referred to, which has charge of business only outside of New York City, has about 150 employes and clerks or the payroll. 




