

Omaha's First Burying Ground.

In 1858 the pre-emption claim of Moser F. Shinn was away out porthwest of the hamlet of Omaha, and even the most daring mind saw no prospect of that piece of land becoming the center of a city big and wide and great enough to be listed high among the aggregated groups of population. Today a portion of the Shinn claim is comprised in Prospect Hill cemetery, which comes as near the center of the platted and built-up area of the city as can very well be named without exact measurement. Mr Shinn gave ten acres of his claim for cemetery purposes. A little later Jesse Lowe added ten acres adjoining; but both Shinn and Lowe retained title to the land thus set aside.

Upwards of 10,000 interments have been made.

The first interment in what is now M'CORMICK NOT COMPETENT Prospect Hill was made in March, 1858, and the body was that of Alonzo F. Salis-Wife of Son of Harvester King Asks bury. He was a member of the council and had represented Douglas county in the third territorial legislature. He was 50 years old when he died. Some among the real old neighbors will recall Salisbury as the owner of the sawmill and wharf that was located long ago at the foot of Nicholas street. In June, 1858, the second interment was made, when the funeral of J. L. Winship occurred.

First Catholic Cemetery.

In the early 60s the Roman Catholics started a cemetery, old St. Mary's, north of St. Mary's avenue and east of what is now Twenty-fourth street. This was O. C. Ord's father had been burind here.
