day's work." This statement, emanating from C. O. Pratt, chairman of the executive committee of the Amalgamated Association of Street motormen and conductors, followed by the deportation of the 450 strike breakers who came from New York ended the strike. The old "swing system" has been abol ished, ten hours will constitute a day's work; all employes will be permitted to purchase their uniforms in the open market; all future differences are to be adjusted between the company and a grievance committee chosen by the employes. If, after an investigation by the city conroller of the books of the company, it can be shown that more than 22 cents an hour can be paid without crippling the finances of the company, the men will insist upon a further advance in wages.
