Mr. Bryan's speech to the delegates of Lancaster county will not affect the politics of Scott county at all, for the reason we have no nucleus in that county and there is no major flight. Mr. Bryan told me that the rank and file of the party is opposed to county fusion. I had nothing to say yesterday. He informed me in regard to getting up a coalition for the state election."

"What are your engagements earlier about your time after the state convention begins?" asked Mr. Latta.

"Oh, I have time to some talk going on. But I have not been outside of my home county and friends don't know what the winds are blowing in the other counties of the state."
