The governor gave no hint of the results and Police Commissioners during the afternoon, except in mentioning the fact that he intended to see that the law was en-Omaha also. ROANOKE, Va., Aug. 6.-Holding a stick of dynamite in his lap, Mayor A. H. Bousman of Ridgeway deliberately lighted the fuse with his cigar in order that his famfly might reap the benefit of heavy insurance which he carried, according to detectives who investigated the mysterious

explosion at Ridgeway on July 24. Bousman was said to be deeply in debt. and it is said he planned to destroy himself in order to save his family. He held an accident policy for \$6,000 and life policies aggregating \$3,000. It is believed he lay on his lawn at night, touched the fuse of a stick of dynamite with his lighted cigar and awaited results. The detectives have officially reported to the town council and their theory of the mystery has been accepted by Bousman's friends.
