AFFAIRS AT SOUTH OMAHA

John Rutz, Burlington Lamp Tender, Killed by Fast Train.
Annual Meeting of Library Board Held, at Which Former Officers Are Re-Elected—Light Registration Tuesday.
John Rutz, a lamp tender for the Chicago, Burlington & Quincy railroad, was accidentally killed Wednesday afternoon on the company's tracks at Thirty-second and O streets. About 4 p. m. two passenger trains passed that point. The last train over discovered the body of Rutz, and the train was stopped and word sent to the local officials of the road. Rutz had evidently been hit by the first train which passed. The wheels had not passed directly over him, but a board lying on the south side of the track on the siding near which were the lamps of the switch which he had been tending. He had a can of oil and had evidently been working at the time. The track makes a short curve near the place and it is thought the fast moving train swept around the curve, striking him before he had time to get out of the way. The deputy coroner, J. D. Larkin, took charge of the body.
