COUNTY BOARD AND CRECHE

Supervisors Ask to Provide Means for Moving Structure.

QUESTION OF LIABILITY COMES UP

County Attorney Heas Thinks County Must Pay for Persons Sent to Home by Police as Well as Juvenile Court.

At 2 o'clock this afternoon the members of the board of county supervisors will visit the Creche for the purpose of holding a conference with the building committee of the Associated Charities in relation to needed improvements at the Creche. Two things will be considered. The first will be moving the two-room building recently placed on the Creche property and setting it on a permanent foundation, and the second will be the location for a building to be constructed for use as a place of detention for incorrigible boys and girls.

Matron Johnson of the Creche and Mrs. Phelps of the building committee were before the county board yesterday afternoon with a request for assistance in getting the contagious disease building located on its permanent foundation and made possible to use during the winter. When the building was moved from the Creche property it was left perched upon wooden blocks without any foundation. The women want to have it moved back against the hill and set upon a brick foundation. Mrs. Phelps said that J. E. Hollenbeck had offered to move the structure without charge and L. C. Besley agreed to give the brick required. The county board is only asked to supply the bricklayers.

The new detention building is a more serious matter. A new lot must be purchased for it and the Creche workers desire it to be located as near the parent building as possible. The juvenile court law requires providing such a building and the board is willing to act. Several locations have been examined and others may be looked at today.

The question of liability of the county for the care of children sent to the Creche by court orders was considered yesterday for the first time. Children thus sent are compensated being cared for. The board did not mention the liability of the county to pay for those sent from the juvenile court but doubted the responsibility for those sent from police court, which is the chief source of the supply. County Attorney Heas will give a formal opinion in the matter today, and in a preliminary talk expressed his belief that liability was unquestionable.

The board allowed Matron Johnson \$10 a month for caring for a little two-year-old girl who is totally blind and whose mother died a county charge in the hospital last summer. The child has been at the Creche two months.

Pastors Named for Methodists at Conference

All from Council Bluffs Returned Save Rev. Frank Caldwell, Who is Assigned to Sidney.

All of the pastors of the Methodist churches in Council Bluffs, have been returned with the exception of the Rev. Frank Caldwell of Trinity. He has been transferred to the Sidney church and his place here filled by the appointment of Rev. A. W. Harned, who comes from the central part of the state. Nearly all of the clergymen returned yesterday from Perry, Ia., where the conference was held, lasting more than a week. Bishop Hamilton and his coadjutor are said to have experienced more than usual trouble in making the hundreds of assignments of the ministers to the various churches throughout the southern half of the state. As is generally the case much dissatisfaction was expressed by some of the clergymen over their assignments. Many requests, however, were granted for the return of pastors, when made strongly through the congregation.

An incident of the conference was the retirement of Rev. T. McK. Stuart, after fifty years of continuous active pulpit service. He has reached the age limit when he may be superannuated and that action was taken at his request. Mr. Stuart was pastor of the Broadway church here for several years and greatly endeared himself to his congregation and the people of the city. His son, Attorney D. E. Stuart, leading lawyer, president of the Commercial club, progressive and active in all affairs, is a prominent acquisition of Council Bluffs, and as the venerable pastor always looked upon this city as his home, it may be possible that he will again return here and pass his declining years in closer association with his people.

Superannuate relations were also assumed by A. Thornbue, John Harned and Rev. Mr. Platscher. The conference treasurer reported over \$10,000 of benevolence money brought to the conference by the ministers. Rev.
