OIL RATES BEFORE BOARD

Railway Commission Hears Complaint of Victor Wilson.

CHARGES ARE OUT OF PROPORTION

Request Made that They Be Reduced Approximately Seventy Per Cent, as Now Exist in Kansas.

(From a Staff Correspondent.) LINCOLN, Sept. 28.—(Special.)—The State Railway commission took testimony today on the application of Victor Wilson for a reduction in Kansas oil rates to Nebraska points.

Mr. Wilson submitted several exhibits to show that the rates were out of proportion compared to other rates, and therefore should be reduced.

He asks that the Nebraska rates be reduced approximately 70 per cent, which, then, he says, will make the Nebraska rates about the same as the Kansas rate.

The oil rate question was up before the late legislature and several hearings were given to the interested parties.

Placed Douglas County Bonds. State Treasurer Brian has placed all of the Douglas county court house bonds, which he purchased, and has taken care of the bond issue of the various cities and school districts at the same time.
