Hungarians Try to Blackmail Archbishop

COLMUBUS, O., Oct. 22-Postoffice inspector J. W. Oldfield, of Cincinnati, aided by secret service men and local police early this morning arrested six Hungarians

and said he expected to arrest as many more before daylight on a charge of at empted blackmall.

The alleged victim was Archbishop Julius Vanharossky of Kaloosa, Hungary, who mplained to Bishop Joseph J. Hurtley, of the Roman Catholic church, Columbus Bishop Hartley communicated with Inspector Oldfield, who has been working on the case for more than a year.
