Rodgers of Omaha, and others, to establish a beneficiary society. On the 6th of June, 1890, the infant fraternity was announced. An office was established in Sheely Block. H. J. Root and Ruby H. Root attended to the details of the office, while J. C. Root organized a field force and began the upbuilding of the order. John T. Yates, Sov-Clerk, soon became actively engaged in the duties of his office.

Twenty-one years of effort has resulted in enlisting nearly 600,000 members; establishing two ladies' auxilliaries and promoting co-ordinate jurisdictions in Canada and the Pacific States, making a combined membership of over 800,000 men and women in the system of perfected woodcraft
