



FIRE AT AMUSEMENT RESORT

Chester Park, Near Cincinnati, Suffers Loss Estimated at Hundred Thousand Dollars.

CINCINNATI, Aug. 14 .- Fire broke out at 5:30 o'clock in Chester park, an amusement resort in the northwest part of the city, and in an hour had caused a loss estimated at \$100,000.
