## RAILROADS GRIDIRON STATE

But Four Counties Are Left Now  
Without Steel Rails.

## LA FOLLETTE TO ENTER STATE

Newly Organized League to Have  
Officers at Lincoln as Soon as  
Secretary F. P. Corrick Re-  
turns to the City.

LINCOLN, Sept. 16.—(Special.)—With the construction of the Callaway line of the Union Pacific, there are left in the state only four counties which have no railroads touching their borders: Loup, Phelps, Banner, Keya Paha and Garfield, come very nearly getting into the category, but are saved by the fact that Burlington extensions to Erickson and Burwell pass through corners of each.

According to the new official map just issued by the State Railway commission, other counties barely escaped having railroad facilities, one county being Cherry, across which the Northwestern runs not far from the northern border. Almost sixty miles must be traveled before one can reach railroad facilities to the south. The longest distance one can travel on railroads in the state, according to the new map, is 61 miles from Falls City to Crawford, which is almost as far as the distance from this city to Chicago.

## La Follette Opens Offices.

La Follette headquarters for the state will be opened in this city following the return of F. P. Corrick, secretary of the newly organized La Follette league to this city. Mr. Corrick is at present on a business trip to Indianapolis and is expected to return to Nebraska the latter part of the month.

It is the intention of the officers of the newly organized league for the furthering of the Wisconsin senator's presidential candidacy to wage an energetic campaign in the state from now on, according to statements made by local men associated with the movement.
