Mrs. Woods did not semi her husband to the asylum, but he was examined by the board of insanity and adjudged insane. She and her son were instrumental in getting his release some time ago. H. M. Sullivan, counsel for Mrs. Woods, discovered that Woods was quietly living at Reno preparatory to getting a divorce. He went there and persuaded Woods to transfer two-fifths of his property to his wife, which amounted to about \$25,000 and then agreed not to fight the divorce. 


