

AFFAIRS AT SOUTH OMAHA

Farmers Becoming Alive to Value of Stock Yards Fertilizer.

GETTING READY FOR ELECTION

City Clerk Good Making Preparations as Rapidly as Possible for Vote Next Tuesday—Whitmore Back from South.

On behalf of the Farmers' congress, Secretary W. F. Delano of Lincoln and Broken Bow called at the stock yards to register a protest against the incineration of manure and fertilizing refuse by the Union Stock Yards company.

From the state university letters of about the same drift have come to Colonel E. Buckingham, general manager of the company. Dean E. A. Burnett of the university deplored the loss to the farmer that will eventuate from the burning of such valuable soil fertilizer. He stated that all the refuse and manure of the yards could be used within a radius of ten miles from Omaha. Thirty miles from the Gate City, he said, the farmers along the railroads would be able to dispose of it all.

Regent W. G. Whitmore of the state university, in a letter of the same trend, asked that some further means be taken to awaken the farmer to the loss sustained in permitting the yards to burn the waste material that would enrich the soil a hundredfold.

The truth of the matter, said one of the officials, is that the farmers are willing enough to profit by the offer of the yards company to give away the manure and refuse, but the railroad have been unable to quote a rate sufficiently low to allow the farmer to take advantage of the offer.

As the matter now stands the stock yards company seem to feel that the farmers should have awakened to the value of the idea some time ago. Now the plans for the incinerator have been made and a contractor has been found to take the fertilizer, which will be chemically treated and sold at a high profit throughout the south and southwest. It is estimated that 20,000 tons of raw material will approximate 2,000 tons of finished fertilizing powder.

Get Ready for Election. City Clerk Frank Good and Mayor Trainer are today making every effort to prepare for the primary election next Tuesday, in conformity with the direction of the court.

Yesterday afternoon and last night political circles were astir with preparation for the fray. Treasurer E. P. Roggen and E. E. E. Higginson returned from Lincoln, where they had been to examine the records of the house and senate.

As soon as the two returned they made a report of their findings to Mayor P. J. Trainer and City Treasurer John Gillin. Later the mayor declared that the findings of Deputy Treasurer Roggen were practically in accord with the decision of the court.

"The matter is more serious than appears on the face of it," said Deputy Treasurer Roggen after his arrival at the city hall yesterday evening.

"Those who are acquainted with the charter say that the whole business can be knocked out section by section. In event of this the city will be put to explain certain issues of improvement bonds authorized by the last charter."

Coming nearer home it appears that the names of those only who filed personally with City Clerk Good shall be allowed on the ballots. This will make necessary a large supplement of names after the primary.

Mayor Trainer as he left the city hall last evening stated that the decision of the court was conclusive as far as the election went and that he was doing all in his power to carry out the instructions of the court.

Whitmore Back from South. Fresh from the tropics, where he has spent several weeks' vacation, Jess T. Whitmore, general manager of the Grand Island stock yard, visited yesterday upon Colonel E. A. Buckingham of the Union Stock Yards company.

Mr. Whitmore and a party have just completed a tour to the Panama canal, which he finds to have little in common with the state of Nebraska. Mr. Whitmore commented favorably upon the sanitary condition of the canal zone, where he said yellow fever was becoming a bug bear of the past and steptomias were at a premium.

Mr. Whitmore said that the recent savings in at the canal were immaterial and altogether of minor import to the engineers, who have calculated upon such happenings. He expected that the canal would be open for traffic about the first of 1913.

County Board Defers Action Upon Distress Warrant on Company

After John F. Stout of Stout & Rose, counsel for the Omaha Water company, and R. B. Howell of the Omaha Water board, had wrangled before the Board of County Commissioners for two hours yesterday on the matter of the company's application for a refund of the \$35,000 tax assessment it had paid, the board took the advice of County Attorney James A. G. Ellick and indefinitely deferred action yesterday afternoon.

Stout renewed his plea that the \$35,000 tax, paid on the assessment against the company's \$334,000 judgment, was paid by error and should be refunded because County and City Treasurer Ure has ordered the sheriff to serve a distress warrant to satisfy a \$35,000 assessment against the physical property of the company. Should the \$35,000 assessment be collected and the \$35,000 be refunded it would be a case of double taxation, said Stout.

Howell contended that both taxes should be collected, with the understanding that when the courts finally have determined whether the company owns a water plant or a judgment against the city one tax or the other will be refunded.

The meeting was enlivened by exchanges of unpleasantities by Stout and Howell, Stout having the better of it. Stout accused Howell and the water board of spending \$60,000 of the city's money trying to keep from taking the water plant, called Howell the master of the Board of County Commissioners and referred to several of Howell's statements as "trucks."
