





Application must be made at the \$30,000 alleged to have been paid her to The bonds are of the regular registered We must preserve to the American stor presecution of the Omaha man on coupon series, drawing 2½ per cent inure of the United States, after one year from the date of the bond. They are in denominations of \$20. \$100 and \$500 Whenever they are paid the government is obligated to make full payment in gold which she had agreed to deposit in trust coin. The bonds will not be ready for delivery before August 1, but will draw interest from July 1. The amount allowed one depositor is not limited. The bonds are exempt from taxation, and should be soon commanding a premium. They may be registered and then the holder can lose them by neither loss, destruction or theft. Bonds registered in

the name of a minor can only be assigned or transferred by a duly appointed guardian of the holders. If holders desire at any time to cash in the bonds they may be sent to the board of trustees, properly endorsed, when they will be redeemed at par. It is expected that many thousand dollars will be converted into bonds by Council Bluffs people at this purchasing period.
