TO START MOVE TO BAR COMMERCIALIZED BOXING

LOS ANGELES, Aug. 20 .- Initiative petitions toward a state law prohibiting long duration boxing exhibitions or those professionalized, either by gate receipts or prize awards, will be circulated immediately throughout California. This was decided late today by a committee of the Los Angeles Church federation, which waved aside protests of those interested




