FEDERALS SHYING AT EVERS

Outlaws Declare Deposed Cub Manager Belongs to Nationals.

WEEGHMAN MAKES STATEMENT

Asserts Fact Tinker Arrived in New York in Time for Conference with Him and Gilmore Doesn't Lean on Case.

NEW YORK, Feb. 12.—A new angle developed in the base ball situation today, when the Federal league promoters announced that they would not bid for the services of Johnny Evers, deposed manager of the Chicago National league team. Charles H. Weeghman, the leading backer of the Federal league, stated that his organization considered Evers under contract with the National league and conforming with the new league's announced policy would make no effort to obtain Evers.

Looking for Ball Park. Immediately after making this statement Weeghman, Gilmore and Tinker hurried from their temporary quarters and it was reported that they were again viewing possible sites for a base ball park in Greater New York for 1915, if not this year.

Evers failed to appear in the gathering of managers and other followers of base ball. He left his hotel early in the forenoon and could not be found in the usual gathering places. President Gaffney of the Boston Nationals reported that he could not find Evers, although he had been on the outlook for him.

Refusance from Murphy. Charles W. Murphy, president of the Cubs, denied that he had any intention of retiring from professional base ball or that he knew of any move to force him out of the National league. He said: "I am in the game to stay. It has become the national pastime to kick Murphy out of base ball at least four times a year, and I am getting used to it. I am the master of my soul—the real and only boss of my ball club—and I am going to run it in the way I see fit. These knucks I receive with a great deal of happiness, because they help to fill the ball park with haters of Murphy who have paid their gate money to help make Murphy rich."

COULD SMASH BRITISH EMPIRE IN A SINGLE DAY

LONDON, Feb. 12.—"You could easily smash the British empire in a day's debate in Parliament if you tried to interfere with the autonomy granted to its various parts," was the statement of Lewis Harcourt, secretary for the colonies in Parliament today. He was replying to an amendment moved by the labor members in the House of Commons to the address in reply to the king's speech.

The labor members had urged that the government withhold its assent to the bill of Premier Louis Botha of South Africa, indemnifying the South African government for its act in deporting the labor leaders after the recent general strike there.

Without defending the action of the Botha government, Mr. Harcourt pointed out that there were in South Africa only 1,250,000 whites to 5,000,000 natives who when work had ceased at the mines became hungry and dangerous. He added: "That in the sort of volcano on which everyone was sitting in South Africa."

Mr. Harcourt declined to advise the king to withhold his sanction from the bill if it passed and he declared that such advice would be entirely unjustifiable. He urged the speakers during the debate to be careful of the rights of the self-governing dominions and to refrain from saying anything derogatory to an autonomous government.

Alleged Ritual Murder Near Kiev.
