FALLS CITY, Neb., Nov. 5.—(Special Telegram.)—The republicans made wonderful gains in this county at yesterday's election. The county went republican with the exception of register of deeds and county superintendent. Official returns from the twenty precincts show the state ticket, Morehead, 2,300 against Howell's 2,054, a majority of 146 for Morehead, where his majority in 1912 was almost 1,100. Reavis polled 2,394 against Maguire's 1,654. For representative from the First district, Reichick (dem.), defeated Ayres (rep.), 2,044 to 1,624. In the Third, Howe (rep.), 2,066, over Parriott (dem.), 1,997.
