

MOST LAWMAKERS FARMERS

Next Session of Legislature Will Contain Over Fifty of Them.

FOUR LAWYERS IN THE LIST

Four Newspaper Men Also Are Members, All in Lower House, While There Are Fifteen Merchants.

(From a Staff Correspondent.) LINCOLN, Neb., Nov. 28.—(Special.)— Farmers will predominate in the next session of the legislature to a large degree according to the statements furnished the secretary of state so far for the roster of jegislative members. Although but ninety of the 100 members of the house have reported, thirty-six of them are farmers, while of the thirty-three members of the senate, eleven are farmers This makes 47 members so far in the agricultural class. When the other ten in the house have reported it is probable there will be over fifty farmers in both

The last legislature also was to same extent a "farmers" legislature, thirtysix being tagged that way in the house while five were found in the senate, a doubt safe to say that this session will be more agricultural than any for some

Roster of Lawyers.

In the 1913 session there were eleven lawyers in the house and seven in the senate, While in the present session there one doctor in the house and one in the senate. This session will have three ! the house and one in the senate.

There were very few newspapermen in the last session. Dennis Cronin of O'Neill being the only one in the house, and W. H. Smith being the only one in the senate. This session Cronin comes back to the house again, but he will have with him three other newspapermen, but over in the senate there will be no literary artists, the nearest to it being a printer from Omaha.

In the last senate there were two statesmen who had become so wealthy that crat in the upper body this session. In statesmen to burn, ten of tat class willing to admit that thy could live without any visible means of support. This year just four tag themselves as retired, fwo merchants and two farmers.

How They Line Up. The list so far for the coming session is as follows: Senate, farmers, eleven; merchants, five; real estate and insurance, five; lawyers, four; bankers, three, and one each grain dealer, printer, physiclan, manufacturer and retired. In the house: Farmers, thirty-six; lawyers, twelve; merchants, ten; real estate and insurance, eight; bankers, six; retired, four; newspapermen, four; physicians, two; school teachers, two; bookkeepers, two; mechanic, manufacturer and telephone manger, one each. There are ten more to repoot.

One senator in the coming session gives his business as an "ex-sheriff," and one in the house as an "ex-county clerk."

ENGLAND WILL PROPOSE CUTTING OFF BOARDS (From a Staff Correspondent.)

LINCOLN, Nov. 28. (Special.)-In the nterest of moral reform, Judge W. H. England, philanthropist and reformer, innounces that he proposes to go before the next legislature and demand that two things be done for the betterment of mankind.

One of these is the abolishment of the State Board of Secretaries, connected with the Board of Health, and the other is the throwing out of office of the members of the State Board of Pardons.

Judge-England does not believe that any board has any right to deny any physician, who desires to come into Nebrasks and practice, the right to do so. He believes that it is all in the interest of a medical trust and the judge believes that trusts are "agin the government." As far as the pardon board is concerned, the judge is opposed to the principle of bringing matters of pardon and parole before a board for a hearing. He believes that the warden should be the all-powerful judge and from his decree there ought to be no appeal.

EXAMINER ROBINSON REPORTS ON SHORTAGE

(From a Staff Correspondent.) LINCOLN, Nov. 28. - (Special.)-Acrding to a report filed with the state auditor by E. J. Robinson, examiner, the shortage of J. W. Hill, county treasurer of Banner county will amount to \$297.41, estimating from the figures at hand. In the report Mr. Robinson says:

As the commissions cannot be settled definitely until the end of the year, we have estimated the same as near as possible, and tax receipts No. 98, 59 and 190, amounting to \$53%, which seems to indicate that the treasurer had not received the money for same and were held for payment, making a total of \$703.49. The Hanner County bank shows a deposit of \$11,825.57 on hand, it appears that at least two checks amounting to \$5.50 have not been paid, which would leave the balance \$11,877.67, providing there were no other checks out. The total cash and balance on these figures would be \$12,890.66, leaving a shortage of \$357.41 estimated on the figures as shown above.


