Boston and Browns Divide Double-Header in Beantown.

TRIPLE PLAY IS FEATURE

BOSTON, Aug. 10.—The Boston Americans lost ground in the race for the American league pennant in an even break with St. Louis today, losing the first game, 5 to 2, and winning the second, 10 to 1.

A triple play by the victors, the first in a league game in this city within the memory of the oldest fan, featured the second contest. Shotton caught Hobbles' fly after a long run in, threw cleanly to Sliser at first base, catching speaker, and Sliser threw home, where Severid tagged out Janvrin. Koob's fine pitching and long hits by Austin and Sliser decided the first game for the victors.

England Started the War Because of Envy and Fear

BERLIN, Aug. 10.—(By Wireless to Bay-Wire.)—The following was given out today by the Overseas News Agency: "The Voelische Zeitung and the Berliner Tageblatt comment at length on the latest official publication of Belgian diplomatic reports found in Brussels. They say these documents prove conclusively that England prepared systematically for the great European war by drawing closer and closer the previously loose members of the diplomatic and political net about Germany, frustrating all attempts of the German government to maintain peace. England is the real and unscrupulous criminal, which plunged the world into a carefully prepared war for the most selfish motives—envy and fear."

FEAR WEALTHY FARMER HAS ENDED HIS LIFE

ASHLAND, Neb., Aug. 10.—(Special Telegram.)—No to a late hour tonight, no trace has been found of the whereabouts of Charles B. Wortman, a wealthy farmer who escaped about 4 o'clock Monday morning from the home of his daughter, Mrs. Earl W. Richards, in this city, where he had been in a critical condition for several months. Harboring the hallucination that someone was trying to induce him to sign away his property, consisting of more than a section of fine Cass county farm land lying along the Platte valley between Ashland and South Bend, Wortman had resisted all efforts of his relatives to take him to the home of his daughter, Mrs. Barnes, at Iowa City, Ia., today where it was hoped a change of surroundings would prove beneficial.

In some manner Wortman, who is about 55 years of age, nearly blind, lame and apparently unable to walk, escaped from the second story of the Richards home through a window, a distance of ten feet, in the early morning and, although searching parties have hunted the country adjacent to Ashland, no clue has yet been obtained.

Hood hounds from Beatrice were put on the trail Monday afternoon, but after holding the trail for several hours, leading up to the vicinity of Salt creek, all trace was lost and the hounds were sent back. It was supposed that Wortman endeavored to go back to his farm, five miles southeast of town, and became lost or fell into Salt creek and was drowned.

Wortman had resided nearly sixty years in Cass county, near Ashland, coming here at a time when there was no habitation between the present site of Ashland and Plattsmouth, and had resided here since. Efforts to find his body in or near Salt creek are being made, \$100 reward having been offered by relatives.

It was said that \$10,000 in prizes will be hung up.

MAGEE DISMISSES PARTITION SUIT

Asks that Suit Against Father and Brother Be Thrown Out Day After His Aunt Appears.

LATTER ASKS DEEDS BE VOIDED

Jerome P. Magee has dismissed his partition suit in district court against his father, Henry W. Magee of Chicago, and brother, Wayland of Omaha, in which he sought title to the greater part of the estate of the late Colonel James H. Pratt, his mother's father.

A one-half interest in the estate sold to Jerome Magee by his aunt, Mrs. Margaret Pratt Olson of Otergotland, Sweden, was a part of the share claimed by him.

Asks Deeds Set Aside. Mrs. Margaret Pratt Olson of Otergotland, Sweden, daughter of the late Colonel James H. Pratt of Omaha, and heir to a half interest in the estate, yesterday asked the district court to set aside deeds by which she had granted her interest in Summer Hill farm at Benson and a large tract of land in Wyoming to Jerome P. Magee of Omaha.

Her interest in Summer Hill farm, Mrs. Olson alleges, is worth \$100,000 and her equity in the Wyoming land is valued at an equal sum. She sold her interest in the properties, the petition alleges, at a price of \$40,000, of which, it says, she received \$15,000 cash and the remainder in securities still in the possession of Jerome P. Magee.

Jerome P. Magee is a nephew of Mrs. Olson. His mother, Mrs. Henry W. Magee, and Mrs. Olson were heirs to the estate of Colonel Pratt. The petition asked that Mrs. Olson in making the sale of her interest in the estate relied on the fact that Jerome P. Magee was her relative and was her attorney. She received no information concerning the value of her equities except the representations made by him, she alleges. The sale was made when Jerome P. Magee visited his aunt at her home in Sweden.

The suit is a climax to charges made at a hearing before District Judge Sears in last spring by Henry W. Magee of Chicago, father of Jerome P. Magee. The elder Mr. Magee then declared he was endeavoring to protect the interests of Mrs. Olson. He persuaded the judge to allow him to go to Sweden to consult her. She returned to Omaha.

A partition suit brought by Jerome P. Magee against his father and brother, Wayland Magee of Omaha, is pending in district court. The hearing last spring was on a motion filed by the elder Mr. Magee asking delay.

At that time the defense was surprised when J. A. C. Kennedy appeared in court with a power of attorney signed by Mrs. Olson in Sweden, authorizing him to represent her in the litigation. Mr. Kennedy sat at a table in the court room with Jerome P. Magee and urged District Judge Sears to sustain the sale of Mrs. Olson's equities to her nephew.

Colonel James H. Pratt died November 12, 1860. Since that time his estate has been greatly involved in litigation. The litigation has divided the family of Henry W. Magee into two camps, the father and Wayland W. Magee being pitted against Jerome P. Magee. The family is prominent in business and society in Omaha and Nebraska and several other states.

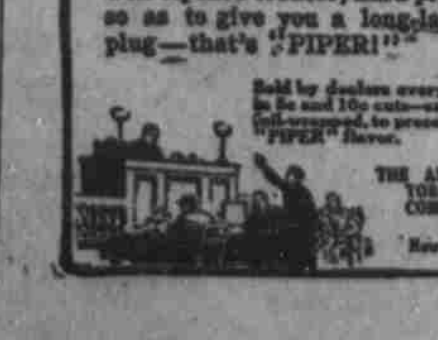
ESCAPED MURDERER IS TAKEN AT DECATUR, ILL.

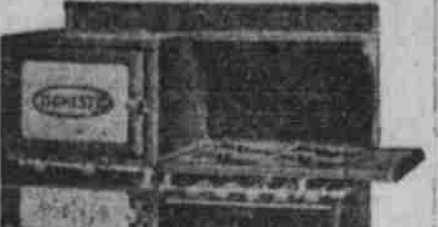
KNIGHTS TO HOLD A PICNIC
