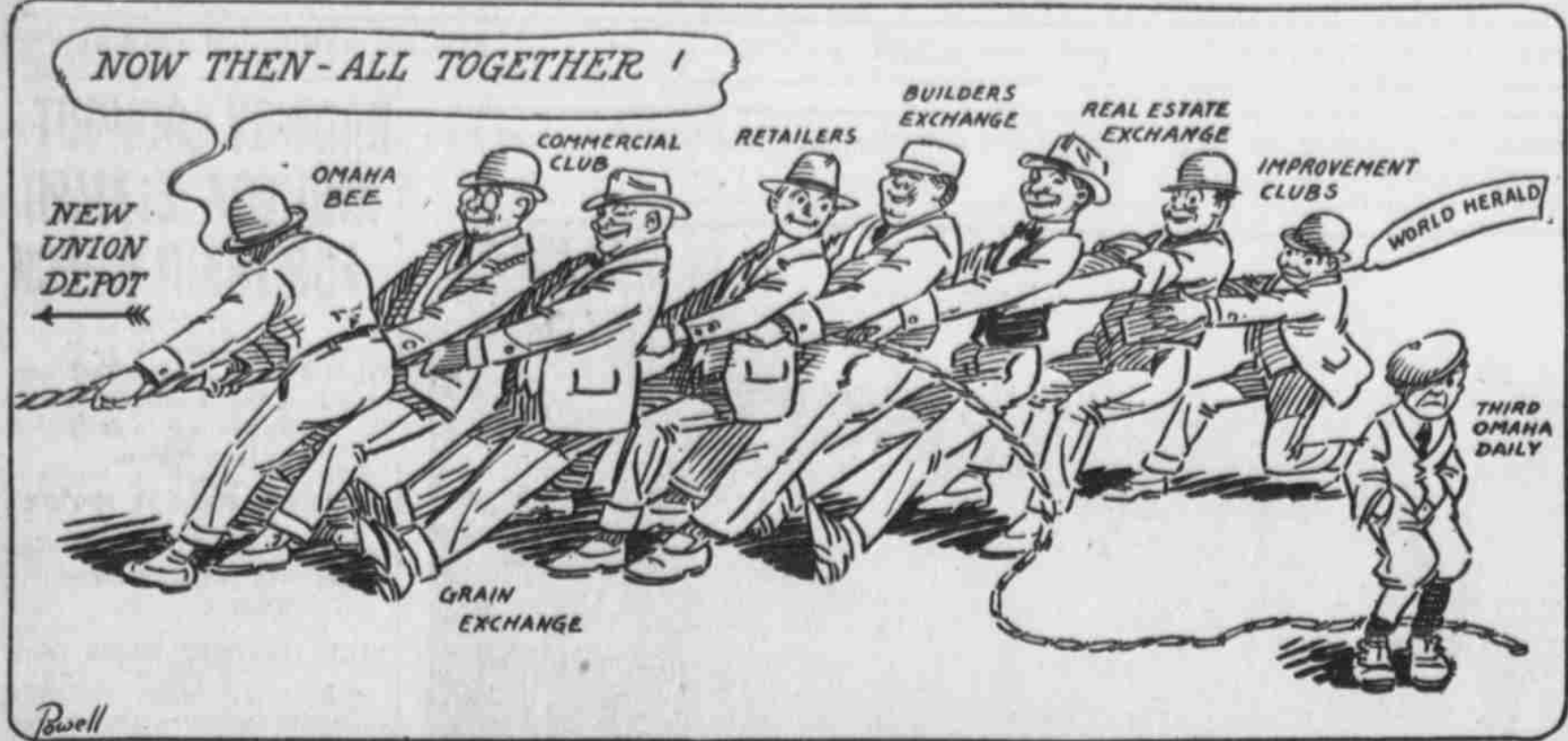

DR. WAITE BLAMES "LITTLE BAD MAN"

Dentist Says He Has Dual Personality, Wicked One of Which Impelled Him to Murder.

JUST WOULDN'T LET HIM BE

NEW YORK, March 28.—Statements indicating that he believed he was possessed of a dual personality, the wicked one of which impelled him to murder John E. Peck of Grand Rapids, his wealthy father-in-law, and Mrs. Peck were made by Dr. Arthur Warren Waite to District Attorney Edward Swann and a detective tonight.

"Oh, it is all over. He did it. This little bad man whom I haven't been able to get rid of until now—he did all. Clara (Mrs. Waite) knows how I have tried to get rid of him. I don't know who he was—he told me he came from Egypt."

Tried to Throw Him Off. Ray W. Schindler, a detective, who visited Waite just before Mr. Swann arrived, declared the young dentist told him about the dual personality, asserting that he sometimes was so obsessed by the "bad man" that he would run around in the park to throw off the inclination.

According to Schindler, Waite told him he administered five bacilli of various diseases to Mrs. Peck, but they did not act as quickly as he expected, he said also, the detective averred, that he fed germs to Peck, but when the results appeared to be "unsatisfactory" he gave arsenic to his father-in-law. Both Peck and Mrs. Peck died at Waite's apartments here, Mrs. Peck on January 20 and her husband on March 12. Autopsies on the body of Peck disclosed quantities of arsenic. Mrs. Peck's body was cremated.

Just Innocent Flirtation. Mrs. Margaret Weaver Horton, who shared a "studio" with Waite at a hotel here, was questioned at the district attorney's office the greater part of the day. Mrs. Horton declared her acquaintance with Waite was "just an innocent flirtation."

Mr. Swann amplified tonight what he said Waite had told him in regard to his "after ego," which he called "the other fellow."

"I have never seen him," Waite is said to have declared, "but I have heard of him. He was born in Egypt in the present life, but lived in other ages. All my evil inclinations came from him. Because of him I often told Clara I wanted to be alone. Until now I have always felt the influence of my alter ego, but feel free now. I feel that for the first time I have cast him off and my mind is at rest."

The railroad officials as the cause of the disaster. The towerman, it was said, had been without sleep most of the time since Sunday night, his wife being ill and requiring his attention when he was not on duty.

When the half dozen investigations already under way are concluded, the blame will be fixed.

W. F. Schaff, district superintendent of the New York Central lines said today:

"The towerman can have nothing to do with the cause of this wreck. The explanation lies between the engineers and the block signal system. We tested out the block signal system this morning after the wreck and found it was working perfectly. After the wreck, Engineer Hess and his brakeman, A. H. Gates, with Brakeman William Blakemore of the Twentieth Century Limited walked back to the signal which Hess drove by. They all said they found the signal was red, or blocked then."

Scenes of Confusion.

Scenes of confusion followed the collision. Many of the injured, plied in the wreckage, called for help as uninjured passengers half clad, emerged from the sleepers and joined with the trainmen in the rescue work. Fireman from Amherst were the first arrivals and succeeded in pulling out a fire which started in the one wooden coach on train No. 86, now known as the "death coach," because of the fact that most of the fatalities occurred in it.

The wreck occurred shortly after 3 p. m. and it was near 4 o'clock when

something like organized relief work was begun.

Hospitals in Lorain and Elvira tonight were filled with injured from the wreck and it was believed generally the death list would exceed above thirty, the first figures announced.

De Heroic Work.

Hospital trains were run from Cleveland, Elvira and Lorain to the scene of the wreck and physicians and ambulances were rushed from all of these points. Hundreds of villagers and firemen from Amherst and vicinity did heroic work in caring for the dead, dying and injured. Most of the dead were manied beyond recognition.

Many of the dead probably will go to their graves unidentified. Most of those killed were asleep in the rear coach of the first section of No. 86 at the time of the crash.

Nude Bodies Invariably Mangled. The bodies of many of these scantily-clad victims are so horribly mangled that identification without the guidance of their clothing will be impossible.

Some of the victims were decapitated. Arms, legs and portions of human bodies were scattered thickly through the wreckage.

Relief parties collected the remains of

three bodies—those of a woman and two men—and piled them, indiscriminately, in one basket.

Alfred Fritzele of Cleveland was in the Toledo sleeper of the first section and escaped injury. He helped in the rescue work.

Aaron De Ray, Pittsburgh, said he was catapulted from his berth into one occupant by a woman across the aisle when the crash came. De Ray was uninjured.

A. Comensky, Pittsburgh, coming from Chicago, said he saw a woman die in the wreckage before he could extricate her. He also saw a man whose arms were torn from their sockets.

When the last named three left only thirteen of the forty occupants of the day coach were accounted for. They placed the number of dead at between twenty-five and thirty.

According to Fritzele and De Ray, the first section stopped five minutes after it left Amherst, and was just picking up speed again when the first crash came. Two minutes later, they said, the second occurred.

CARRANZA GRANTS USE OF RAILROADS

Supplies May Be Shipped to Mexican Firms with Which Army Has Contracts.

WILL FACILITATE THE PURSUIT

WASHINGTON, March 29.—General Carranza has agreed to permit the movement of supplies to the punitive expedition in Mexico over the Mexico-Northwestern railroad. The supplies will go as commercial freight to concerns in Mexico with which the army has contracts.

The permission for use of the railroad is not granted in a military sense and does not cover the movement of troops, for which the American army has not asked. It will, however, enable General Pershing's force to get supplies in abundance in a country where motor truck trains cannot carry them and will thus aid immeasurably in the pursuit of the Villa bandits.
