
OMAHA'S DAYLIGHT SNOW WHITE INDEPENDENT PACKING PLANT ANER PACKING

This plant will be a model of its kind from an operating and sanitary standpoint. The floors will be so constructed that a hose can be turned on and each floor scrubbed and flushed on the same plan as the deck of a battleship.
