



## **Public Utilities Charge All They Can Get**

But after Harry B. Zimman's service as city councilman, the Omaha public service corporations couldn't get as much as they had before.

Zimman, after a spirited fight, forced a reduction of \$1 per month in the charge for residence telephones.

Zimman secured the passage of an ordinance providing for universal street car transfers and for the sale of street car tickets to school children at half price. He tried to get four-cent fares for everybody.

Zimman secured a reduction of electric light rates to consumers.

Zimman forced both the gas and the electric light companies to lower their charges to the city for street lighting.

Three years ago Zimman was a candidate for the city commission on a platform calling for 6-cent electric light. He was not elected, but the campaign he and his comrades made forced the light company to concede the 6-cent rate after the election.

The public utilities companies are now talking about raising their rates.
