Official Statement Says One Person Killed and Six Wounded During Seoul Outbreak.

KOREAN TROUBI

Washington, April 24.-An official statement by the Japanese embassy today, characterizing as exaggerated current reports of cruet measures employed by the Japanese authori-ties in suppressing Korean disturb-

ances, says one person was killed and six wounded in outbreaks at Seoul, and that the total number of casualties in the provinces has been 331 killed and 735 wounded. The embassy's statement follows:

"The exaggerated character of the current reports about the cruelty of measures employed by the Japan authorities in suppressing the Korean disturbances is more than borne out by an official dispatch reaching the apanese embassy today.

"Only one person was killed and six wounded in Seoul from the start of the disturbance until very re cently. The number of casualties in the provinces is all told 331 killed and 735 wounded. 


