"SHALL THE CITY COUNCIL OF THE CITY OF OMAHA BE AUTHORIZED TO ISSUE AND DISPOSE OF GENERAL BONDS OF THE CITY, NOT EXCEEDING IN AMOUNT TWO HUNDRED FIFTY THOUSAND DOLLARS (\$250,000.00), TO RUN NOT EXCEEDING TWENTY (20) YEARS FROM DATE, TO BEAR INTEREST NOT EXCEEDING FIVE PER CENT.
