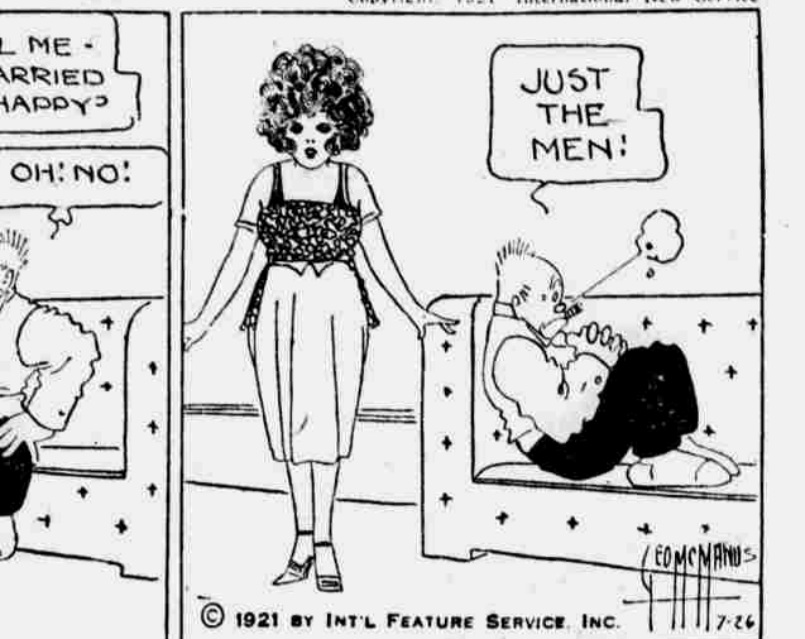

Nebraska Grain

Rate Higher Than That of Colorado Charges Not Controlled by Distance But by "Reasonable" Reply to Protests.

Western Nebraska farmers shipping their grain over the Union Pacific lines pay a much higher freight rate than do those in western Kansas and eastern Colorado, though their distance from Missouri river markets is about the same.

In reply to protests from Mr. Tunison, W. S. Rodman, president of the American State bank at Kimball, J. A. Kuhn, traffic manager of the Omaha Grain Elevator, and C. E. Childs, traffic manager of the Omaha Chamber of Commerce, it is stated by the general freight agent of the Union Pacific, Charles J. Lane, that he has never met a man competent to pass definitely on the precision of any given rate.

In reply to Mr. Lane, who indicates his belief that wheat growers of Kimball and other western Nebraska points are not entitled to rebates as grain from Kansas City, the first statement of your letter is that you have never met any one competent to pass definitely on the precision of any given freight rate.

You state that I have seemingly singed out a shipping point near the Kansas-Colo. line, Chemung, substantially the same distance from Kansas City as is Kimball, Neb., from Omaha. I own land and am raising wheat at both points and because of this fact became acutely aware of the difference in freight rates.

"With respect to the rates you mention at the conclusion of your letter, from points in other states to terminals in other states, none of which are on your system, it seems to me that the applicability thereof to the subject under discussion is doubtful. The railroads who make the hauls in question may not be able to operate as efficiently and through as rich a country as does your system, or they may operate more efficiently and through a better country. In either case, the rates you mention do not afford a concrete, actual basis for comparison, such as the Chemung and Kimball rates do afford."
