





LOCATION

These 221 farms are located south of Torrington, Wyo., on the line of the Burlington Route through the North Platte Valley. This locality is readily reached via Alliance, Neb.; Brush, Colo., or Denver, Colo.

### CHARACTER OF LANDS

This area is part of the valley of the North Platte (the American Nile), where the soil is adapted to the raising of sugar beets, potatoes, alfalfa, wheat and other grains.
