# Larsen Challenges S. V. A. Plane Pilot To Fly Race Again

Donor of Trophy Offers \$10,-000 as Inducement for Another Contest After Appealing Award to Court.

John M. Larsen, donor of the Lar-sen trophy, offered late yesterday to put up \$10,000 as an inducement for Pilot E. F. White to fly another race under the same rules as the Larsen race, against the JL-6 (Larsen) "I'll relinquish all claim on the

prize money for the race flown Saturday if White beats my ships in a fair race," said Mr. Larsen. "I noticed he offered to fly the race over again. Now is his chance."

Obtains Injunction. Mr. Larsen obtained a temporary Mr. Larsen obtained a temporary injunction in district court yesterday, which restrains Acro congress offi-cials from paying Wsite, who was awarded first prize by the contest committee, the \$3,000 which is to go to the winner.

Alleging that White's victory was due to fraud and deception in that gas tank which was not figured in the gasoline consumption computa-tion of the race result, Mr. Larsen asserts that his two planes are en-titled to first and second places and that the decision of the contest com-mittee awarding the event to White mittee awarding the event to White is illegal.

Owner to Fight Action.

His suit was directed against A. H. Fetters, member of the Aero congress protest committee; Maj. Ira A. Rader, chairman of the aviation contest committee; Guy Kiddoo, head of the congress finance committee, and White. C. B. Wrightsman of Tulsa, Okl.,

owner of the S. V. A. ship, has re-tained counsel to fight the legal action brought by Mr. Larsen. "I don't need the money," Wrightsman said. "If my plane is not entitled to first place it is not entitled to any prize at all. We'll fight the thing out."

Hearing of the temporary injunc-tion was set for November 12.


