# Haywood Will Return,

Chicago, March 15 .- William (Big Bill) Haywood, leader of the I, W. W., who fied to Russia to escape a 20-year sentence in the penitentiary for obstructing the efforts of the United States during the war, will teturn, despite reports that he is the head of a soviet syndicate to develop mining fields, Otto Christenhis attorney and one of his sen, bondsmen, said today.

"Haywood promised to return to haywood promised to this the set in Russia has been completed," said Mr. Christensen, "and I believe he will keep his word. This mining development plan is nothing new to me. I have heard of it for months. I believe that the soviet government suggested it to Haywood as a means of getting exiles like himself to work, instead of being forced to take care of them.


