Chambers, Neb., April 28.—(Special.)—Herman Glampe, 38, was found dead in a stall of his barn one-half mile west of here. A shotgun and a bottle of formaldehyde were near the body.

A coroner's jury, empaneled by Assistant County Attorney Gallagher and Sheriff Duffly, gave a verdict of suicide.

Glampe lived on a farm which was the property of his father. He was married and employed by the family of William Gumb, jr. to keep house and assist him with the farm work.
