McLellan the sum of \$213.00 and interest from said 20th day of November 1894 now due by reason of a written contract made and entered into by and between the plaintiff and the defendants herein on the 12th day of June 1893 whereby you the said defendants agreed to furnish for a period of one night to-wit Monday January First 1894 The Pauline Hall Opera Company to give a performance in the Lansing Theatre at Lincoln Lancaster County Nebraska, of which Theatre said plaintiff is manager, and in said contract it is agreed that the receipts from the sale of seats for said performance of said Pauline Hall Opera Company were to be divided as follows twenty five per centum thereof to belong to said plaintiff and seventy five [75] per centum thereof to belong to said defendants and plaintiff and defendants were to have and receive their respective shares of said receipts as aforesaid.

Under which contract there is now due and owing the plaintiff from the defendants and each of them by reason of their failure to perform their part of said contract, although plaintiff at all time stood ready and willing to perform his part thereof, the said sum of \$213.00 and interest from said 20th day of November 1894 at 7 per cent per annum and costs of this proceedings which is now due and owing to the plaintiff from the defendants in said action and that on the 20th day of November 1894 the plaintiff caused an order of attachment to be issued out of said County Court and that the sheriff of said county to
