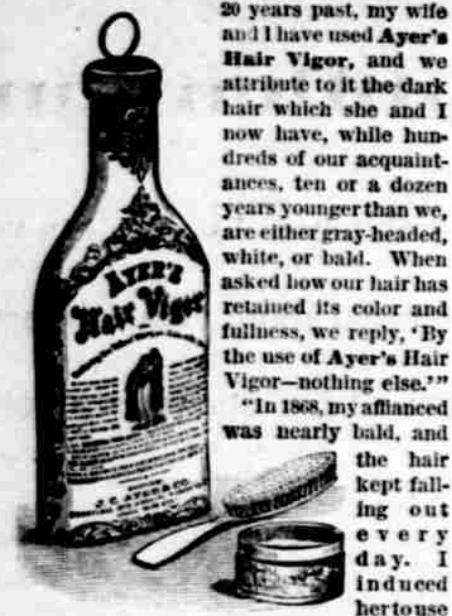

There are 89 turf organizations belonging to the American Trotting association in Illinois.

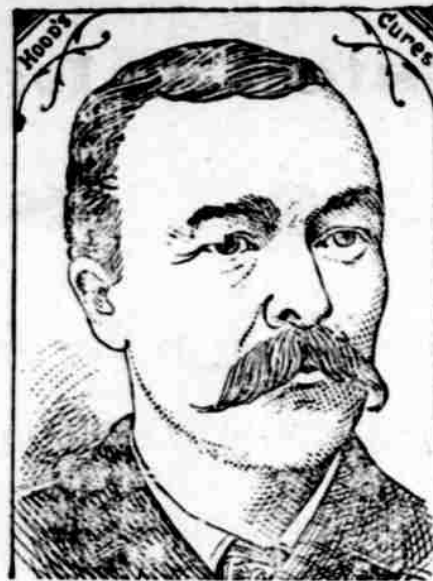
George Gould will not own a racing stable this year, but may go in for turf honors next season.
