"On the 15th day of June 1856, forty-four years ago day after tomorrow, John D. Prey and his son, John W., landed at or near the salt basin, and were the first that came with the purpose of making this their permanent home. Immediately came the Doe family, and in a short time the new settlement contained a goodly number, among them the names of, Keys, Gregory, Cadman, the Loders, Retzlaff, Wollingford Donivan, Moraan, Queen, and so I might go on, names all familiar to you, with the blue blood of the pioneer, that came in the Mayflower, coursing in their veins; they came for a purpose, not alone to satisfy any personal ambition but to build for posterity that which we enjoy today. Those were days of great hardship, their privations were extreme; it was a time when men's souls were tried with equal severity to those their fathers endured in establishing the New Republic. When you remember Captain Donivan, Gregory, Warnes, Wollingford, Loder and Wood, perhaps one or two others, it seems to me now there were eight in number, mounted on their jaded horses, armed with rifles, patrolled the bleak and lonesome prairies to protect the settlers from the marauding movements of the bloodthirsty Sioux, now dealing with the mischievous Cheyennes, then treating with the troublesome Arapahoes, all with a courage and determination of purpose that must convince you that they were of the same stock, were selected for the same purpose, as was Staadish, Winslow and others who came on the same mission over a century before them.

"It was not alone, however, in the men that the work was to be performed, but they were strengthened, encouraged and sustained by the noble women that came with them and endured the awful privations uncomplainingly, and with that degree of fortitude that is again convincing that they were chosen because of that peculiar and perfect fitness for the mission that brought them, and when Mrs. Prey was rescuing little Rebecca, single handed and alone from the marauding band of Cheyennes and Arapahoes on that bright, spring day as she played among the wild flowers, but a little ways from where we now stand, wreathing garlands in childish glee, it serves only to illustrate the character and determination of all the women that endured those dangers, privations, distress and sorrow that we might some day be possessed of the blessings and comforts that we now enjoy.

"I wish that the time permitted a careful and more extended review of their lives, of their deeds, of their character, and that I might contribute to their memory the honor that is their due. Jacob Dawson, Elder Young, Doctor McKesson, T. S. Schamp, John Giles, Jonathan Ball, Luke Lavender, Thomas Hudson. And so I might go on, repeating familiar and honored names. Everyone of them, together with their noble, loving and faithful helpmates, earned the reward of their master for the faithful performance of their duties he gave them in charge to do, and the loving memory of a grateful people that have profited by their lives, sacrificed upon the altar of human progress.

"There can be no mistake therefore, when I urge that they came for the great purpose that I have outlined thus briefly in this paper. Pioneers, upon whom we too often look as an adventurous class, drifting upon the tide of humanity, without rudder or compass, such were not the ones whose memory we honor today, and find pleasure in relating the reminences of their past, which certainly will, as the years go by,

"For humanity sweeps onward;
Where today the martyr stands,
On the morrow crouches Judas,
With the silver in his hand;
Far in front, the cross stands ready,
And the crackling fagots burn.
While the hooting mob of yesterday,
In silence all,—Return.
To glean up the scattered ashes,
Into history's golden urn."

"New occasions teach new duties;
Time makes ancient good uncouth;
They must upward still, and onward,
Who would keep abreast of truth;
So before us gleamed her campfires;
We ourselves must pilgrims be,
